HIGHWAY:

Dustin Hofland, Highway Superintendent met with the board to discuss Highway business. Jerry Burger was present. Hofland stated that bridge 46-040-115 (Wade bridge) should be made construction ready in order to improve the chances of getting a BIG grant in the future or it should be evaluated by Holloway to get an estimate on replacement without the grant. The board asked that Holloway give an estimate.

Hofland stated that bridge 46-030-112 on the Amherst Road should have a hydrology study done. The board asked that he proceed with this. Bid letting for the 2025 Chip Seal project will be done at the next meeting.

Monte Hoglund and Karl Kleman met with the board to discuss hiring Kleman to take over as weed supervisor. Bender moved, Kilker seconded to hire Kleman to be trained under Hoglund and to eventually take over as Weed supervisor. Kleman will be a Highway laborer at \$22.00/hour and Weed Supervisor at \$23.00/hour. All members voted aye.

RECESS:

The board recessed out of regular session to enter into Board of Equalization.

CONSOLIDATED BOARD-LANGFORD:

Jason Bender, Andrea Kilker, and Doug Medhaug, were present as members of the Consolidated Board of Equalization of Marshall County, Langford Town and Langford School. Members Orrie Jesz and Cory Cole were absent. Oaths were taken by members present. Kilker moved, Bender seconded to approve the Langford Town assessment book. All members present voted aye. Bender moved, Medhaug seconded to adjourn the meeting of the Consolidated Board of Marshall County, Langford Town and Langford School. All members present voted aye.

CONSOLIDATED BOARD-BRITTON:

Matt Schuller, Lynda Luttrell, Jason Bender, Angela Grupe and Lindsey Kimber were present as members of the Consolidated Board of Equalization of Marshall County, Britton City and Britton School. Oaths were taken by all members. Luttrell moved, Kimber seconded to approve the Britton City assessment book. All members voted aye. Grupe moved, Kimber seconded to adjourn the meeting of the Consolidated Board of Marshall County, Britton City and Britton School. All members voted aye.

EQUALIZATION:

The County Board of Equalization met to hold their annual equalization meeting. Present were Commissioners Medhaug, Kilker, Bender, Luttrell, and Schuller and Director of Equalization Katrina Johnson. Chairman Schuller called to order the County Board of Equalization and oaths of office were completed.

APPEAL:

Johnson presented an appeal on the house value on parcel 25.55.37.M002. The assessor's value was \$261,780, however the owner showed a recent appraisal with a lower value and after review, the assessor agreed that the value should be \$208,725. Medhaug moved, Kilker seconded to approve this value change. All members voted aye.

CORRECTIONS:

Luttrell moved, Kilker seconded to approve the following correction to the assessment book: Parcel 09.55.31.3000 Assessed value from AGA: \$146,713 to AGA: \$138,233 reason: correction to flooded acreage reduction. All members voted aye. Bender moved, Medhaug seconded to approve the following correction to the assessment book: Parcel 01.30.01.0001 Assessed value from NAD: \$142,353 to AGA: \$165,758; reason: The highest and best use is Ag. All members voted aye.

RENEWABLE ENERGY CREDITS:

The Director of Equalization informed the board that there were no new renewable energy credit applications. Total credits for 2025 were \$66,828.

DISABLED VETERAN EXEMPTION:

Bender moved, Kilker seconded to instruct the Director of Equalization to reduce values on all properties qualifying for Veteran exemption. No new exemptions were given. All members voted aye.

ASSESSMENT FREEZE: Disabled and Senior Citizens

Bender moved, Kilker seconded to instruct the Director of Equalization to reduce values on all properties qualifying for assessment freeze for Elderly and Disabled. Total exemption is in the amount of \$2,327,824. Taxable base years are \$1,195,787. All members voted aye.

TAX EXEMPT PROPERTY:

Bender moved, Luttrell seconded to approve the list of tax-exempt property. All members voted aye. A complete list is on file at the office of the Director of Equalization and can be requested during regular office hours.

OWNER OCCUPIED STATUS:

Kilker moved, Luttrell seconded to approve changing status to owner occupied for 4 applications received after assessment notices were sent out. All members voted aye.

ADJOURNMENT:

Luttrell moved, Medhaug seconded to adjourn as County Board of Equalization and enter into regular session. All members voted aye.

PERFORMANCE OF DUTIES:

The board met with Katrina Johnson in reference to the performance of her duties as Director of Equalization pursuant to SDCL 10-3-14.

SHERIFF:

Sam Swanson, Sheriff met with the board to discuss sheriff's department business. Thomas Myers has been hired as a full-time deputy sheriff effective April 8 at a rate of \$24/hour. Swanson also stated that he is in the process of signing an MOU to become part of the Internet Crimes Against Children task force. This will allow Marshall County to assist with investigating crimes in Northeast South Dakota, and in return can get equipment and resources for our own investigations. Swanson is also still working on an agreement with Day County to take over their 911 dispatching in January.

EMERGENCY MANAGER:

Logan Roehr, Emergency Manager met with the board to give an update on radios for public safety. There is an app that will allow cell phones and radios to work together. Roehr will purchase the gateway that allows this to work as Sheriff Swanson looks to get the free app for deputies. Roehr also informed the board that FEMA is currently not reviewing hazard mitigation plans. Also, the LEMPG was cut by 35% for next year.

COURTHOUSE BOND:

Tobin Morris, Colliers Securities, LLC met with the board via teleconference to discuss the varied costs of issuing the bonds and the process of issuing.

LATCF FUNDS:

Medhaug moved, Luttrell seconded to use the \$100,000 of LATCF funds for General Government Purposes. All members voted aye.

FINANCIAL REPORT:

County Auditor Megan Biel presented the following report showing the financial condition of the County Treasurer's office as of the close of business March 31, 2025 FSB \$5,605,523.83 Certificates of Deposit \$3,111,369.06. Cash \$1,050.00. Total \$8,717,942.89. The amounts above include amounts held for others including schools, towns, townships, etc.
