Superintendent Weinberg talked to the board about taking the weight limit off of the roads on 4/21/25. Motion by Nebelsick to take the weight limit off of the roads on 4/15/25. Motion failed due to lack of a second. Motion by Nebelsick to approve taking the weight limits off of the roads on 4/17/25. The motion was seconded by Claggett. Roll call vote was held: Claggett - aye, Nebelsick - aye, Blaalid - nay, Reider - nay. Motion failed due to a tie vote. Motion by Claggett to remove the weight limit on roads on 4/21/25. The motion was seconded by Blaalid. All in favor - aye. Motion passed.
