**CALL TO ORDER**

Chairman Reider called the meeting to order at 5:30 P.M. Members present were Commissioners Claggett, Blaalid, Reider, Mitchell City Council member Doescher, Auditor Wingert, Equalization Director Vissia, and DOE Staff Carla Wittstruck, Jared Olsen, Jason Raymond, and Travis Dammann.

**ADMINISTER OATHS**

Auditor Wingert administered the oath of office to Davison County Consolidated Board of Equalization members.

**ELECT CHAIRPERSON**

Auditor Wingert called for nominations for the 2024 Chairman of Consolidated Board of Equalization. Motion by Reider, second by Blaalid to nominate Claggett as chairman. No further nominations were made. Motion by Reider, second by Doescher to cease nominations, and a unanimous ballot be cast with Commissioner Claggett as 2025 chairperson of the Consolidated Board of Equalization. All members voted aye. Motion carried.

**ELECT VICE CHAIRPERSON**

Called for nominations for the 2024 vice chairperson of Consolidated Board of Equalization. Motion by Reider, second by Doescher to nominate Blaalid as vice chairperson. No further nominations were made. Motion by Reider, second by Doescher to cease nominations, and a unanimous ballot be cast with Commissioner Blaalid as 2025 vice chairperson of the Consolidated Board of Equalization. All members voted aye. Motion carried.

**CHAIRPERSON TAKES OVER THE MEETING**

Commissioner Claggett took over the Board of Equalization meeting as chairperson and continued with the meeting business.

Motion carried 4-1.
