CALL TO ORDER

Chairman Reider called the Davison County Board of Commissioners meeting to order at 9:00 A.M. Members of the board present were Claggett, Kiner, Nebelsick, Blaalid and Chairman Reider. Also present was Auditor Wingert.

PLEDGE

Commissioner Reider opened the meeting with the Pledge of Allegiance.

APPROVE AGENDA

Motion by Kiner; second by Nebelsick to approve the agenda. All in favor - aye. Motion carried.

APPROVE MINUTES

Motion by Claggett; second by Kiner to approve the minutes of the August 19, 2025, meeting. All in favor - aye. Motion carried.

PUBLIC INPUT

Steve Sibson stated that he read about the Dakotafest property tax panel in the local newspaper. Mr. Sibson believes there are three options: shift the burden to another classification, lower revenue, or replace revenue such as a sales tax. He is pushing for legislation to study two things: city TIF's and how they impact revenue and school district capital outlay.

EM/P&Z ACTING DIRECTOR WEGLEITNER

Karen Wegleitner talked to the board about the 2026 LEMPG Agreement. She indicated that fiscal year 2025 ends on 9/30/2025 for the office, and she is finalizing several last-minute tasks. WHEREAS; Davison County created Tax Increment Financing District Number Three on 7/09/2013

WHEREAS; SDCL-11-9-25 States “ in no event may the positive tax increments be allocated longer than 20 years after the calendar year of creation” and

WHEREAS; TIF #3 has been fulfilled prior to the 20 years, being paid off in full
WHEREAS; Davison County is authorized to dissolve this Tax Increment Financing District
number three pursuant to SDCL 11-9-46 (1)
NOW THEREFOR BE IT RESOLVED by the Board of commissioners of Davison County that
the Tax Financing District Number Three be and is hereby dissolved.
BE IT FURTHER RESOLVED that any funds which are deposited in the Tax Financing District
number three pursuant to SDCL 11-9-31, be distributed as provided by SDCL 11-9-45.
