HIGHWAY:

Dustin Hofland, Highway Superintendent met with the board and reported that the highway department has been working on blading, signing, and finishing up mowing. Bridge (now a box) 46-141-000 is almost complete. The highway employees are going to a training day in Day County where they will have training in blading, gravelling, etc. Kilker moved, Luttrell seconded to authorize Shari Schock to sign the license agreement with DWare. All members voted aye.

EXECUTIVE SESSION:

Kilker moved, Medhaug seconded to enter into executive session to discuss personnel issues pursuant to SDCL 1-25-2 at 9:47 am. The chairman called the board out of executive session at 10:11 am. No action was taken.

SURPLUS:

Kilker moved, Medhaug seconded to declare surplus multiple old damaged culverts previously used by the Highway department. All members voted aye.

SUPPLEMENT:

Medhaug moved, Kilker seconded to supplement the 24/7 budget by \$35,000. All members voted aye.

AMBULANCE:

Lori Amerman, Ambulance Primary Advisor met with the board to give an update on the ambulance crew. 2 new EMTs have started to do ride-a-longs. Amerman reported that LPNs and RNs are now eligible to be on an ambulance crew without taking the EMT course. Amerman stated that she would like to have 3-4 more people on the crew to take call by a year from now. The board discussed the Community Health Assessment and one of the main concerns on the assessment was the ambulance service and ensuring that the County is able to continue it.

Kilker moved, Bender seconded to enter into executive session to discuss personnel issues pursuant to SDCL 1-25-2 at 10:58 am. The chairman called the board out of executive session at 11:18 am. No action was taken.

AUTO SUPPLEMENT:

Kilker moved, Medhaug seconded to auto-supplement \$745,164.25 to the highway budget for the BIG grant completed and received in 2025. All members voted aye.

LEPC:

Bender moved, Kilker seconded to authorize the chair to sign the LEPC grant. All members voted aye.

CASH ASSIGNMENT:

Medhaug moved, Kilker seconded to assign \$2.5 million of unassigned general fund cash to County Buildings purposes. All members voted aye.
