HAAKON COUNTY BOARD OF COMMISSIONERS REGULAR MEETING JANUARY 4, 2022

The Haakon County Commissioners met for their Regular Meeting on Tuesday, January 4, 2022 being called to order at 1:00 p.m. by Chairman Mike Gebes. A quorum was established with the presence of Chairman Gebes, Vice-Chairman Nick Konst, Commissioner Tom Radway, Commissioner Steve Daly and Commissioner Lincoln Smith.

Also attending the meeting were Auditor Carla Smith, Deputy Auditor Stacy Pinney, States Attorney Marty Jackley by phone, Library Board President Nancy Thorson, Library Director Bailey Brock, Director of Equalization Amanda Frink, Assistant Highway Superintendent Val Williams, Butler Machine Representatives Jerry Heiser, Phil Melmer and Marvin Royer, and Pioneer Review Representative Tami Ravellette. Public comments were opened and Jerry Heiser from Butler Machine addressed the group. He stated he was retiring and introduced the two gentlemen who will take over his territory and be the county's new contacts.

All motions were approved unanimously unless otherwise noted.

The December 7, 2021 Regular Meeting minutes were read and motion by Radway, second by Smith, to approve. The End of the Year Meeting Minutes from December 28, 2021, were read with a motion by Smith, second by Konst, to approve.

Library Board President Nancy Thorsen introduced the new Library Director Bailey Brock. She started her duties on January 3, 2022.

Response from St Atty Jackley was read regarding the new CDL Federal Regulations going into effect on February 7, 2022. "Unfortunately, the CDL requirement for new CDL applicants is accurate. It does not have retroactive affect which means current CDL's are not affected unless they are seeking an upgrade". Chairman Gebes requested the Auditor Office send a letter to Governor Noem, State Legislators and SDACO Executive Director Kris Jacobsen asking why no opposition was raised on the new CDL regulations from the Governor and Representatives. Assistant Hwy Superintendent Williams presented a letter from Brad Bowers (President of the SD Assoc of County Highway Superintendents) to Meera Joshi (Deputy Administrator of Federal Motor Carrier Safety Administration) stating the issues and difficulties with implementing the new requirements. The letter also asks for a delay of five years on implementation.

Response from St Atty Jackley was read regarding TransCanada Keystone Pipeline Motion to Release Road Bond, Approve Removal of Public Liaison Officer, And Accept Final Reporting. "on the motion to release bond etc. the only thing I would make sure is that paragraph 9 is true and that Keystone has completed it to the county and landowners satisfaction".

DOE Frink discussed a possible increase in the income guidelines for the Elderly Tax Freeze and the assessed property values from \$150,000 to \$300,000. Frink has also been working on correcting the confusion on how the growth process works in the county. Annually, the City of Philip provides a list of building permits at the request of the Director of Equalization, the office then goes and assesses the new construction only at those locations. The State requires new construction to be added in the year of construction to be included in the growth values. The entire property is not reassessed because of the new construction but the value of the new construction is added to the existing value.

Mention was made about Custodian Pinney working weekend hours to get the first floor Men's Restroom painted. The restroom is too busy during the work week to complete the job.

The Auditor's monthly settlement with the Treasurer was submitted and noted below. Contact has been made again to Lowe Roofing. The project is now pushed to the Spring of 2022.

Assistant Highway Supt. Williams reported one of the trucks is broke down and in need of expensive repairs, wanting to hold off to see if Haakon County will be selected in another round of SD DANR rebate program for replacing trucks. Two trucks are still running. A dump truck has been taken to Hoag's for repairs. Rudy Reimann has been hauling gravel for the county, was under contract last year. He can haul again this year if under a certain dollar amount, amount not stated at this time. Gravel projects have been finished on Quinn Rd, working on 10-Mile Rd, Willow Creek Rd and upcoming on Sale Barn Rd. Discussed the Halloway Construction bid for work on Couch Road Bridge, if the project is less than \$100,000 it does not need to be bid out. Still waiting on clarification of the bridge width. County shop had some exposed pipes in a back room that have frozen and burst. Suggested to place an infrared space heater close by. Some counties are looking into options on the new CDL regulations, hoping to train their own employees or co-op with other counties for training/testing.

Emergency Manager Lori Quinn was not available but there have been no new updates on the Hazard Mitigation Plan.

Having completed the old business for 2021, Auditor Smith called for nominations for Chairman. Radway nominated Daly for Chairman, second by Konst. Radway called for nominations to cease and second by Konst. Smith motioned, second by Radway, to elect Daly as Chairman. Daly called for nominations for Vice-Chair. Gebes nominated Smith for Vice-Chair, second by Radway. Radway called to cease nominations and cast a unanimous vote for Vice-Chair, second by Gebes. Smith made a motion to hold the monthly commissioner meeting the first Tuesday of the month beginning at 1 p.m., second by Gebes. Smith motioned to add June 19th to the list of Holidays, second by Konst.

Konst motioned, second by Gebes to approve Resolution 2022-01.

RESOLUTION 2022-03 HAAKON COUNTY BOARD OF COMMISSIONERS PHILIP, SOUTH DAKOTA

January 4, 2022

WHEREAS, SDCL 7-7-20 states that the Board of Haakon County Commissioners shall fix the number of deputies and secretaries, the time of employment and the compensation they shall receive in the offices:

BE IT RESOLVED, that one permanent full-time deputy shall be designated for the office of the Auditor; one permanent full-time deputy shall be designated for the office of the Treasurer; one full-time deputy for the office of the sheriff; one permanent full-time certified deputy for the office of Director of Equalization and one permanent full-time deputy split between the office of Register of Deeds and Sheriff. The Deputy DOE will be hired at \$15.45 if non-certified and \$16.48 if already certified. Certification is to be completed within one year of hiring date.

Starting hourly wage for permanent full-time highway worker has been set at \$15.45 per hour for the first three months if hired without a CDL. Starting wage will be \$16.48 if employee has a CDL when hired or when it's obtained and will continue until the six-month probation is complete. **A CDL must be obtained within the first three months of employment.**

For permanent full-time deputies, starting hourly wage has been set to \$15.45 per hour for the first three months, \$16.48 per hour for the second three months and \$17.51 thereafter. If the need arises for part-time temporary highway workers, the salary rate is set at \$18.03 per hour. For temporary part-time deputies the salary rate is set at \$15.45 per hour.
