DAVISON COUNTY BOARD OF COMMISSIONERS

CALL TO ORDER

Chairman Reider called the meeting of the Davison County Board of Commissioners to order at 9:00 A.M. Members of the board present were Claggett, Kiner, Nebelsick, Reider, Blaalid. Also present was Auditor Wingert.

PLEDGE

Chairman Reider opened the meeting with the Pledge of Allegiance.

APPROVE AGENDA

Motion by Claggett, second by Kiner to approve the agenda. All in favor - aye. Motion carried.

APPROVE MINUTES

Motion by Nebelsick, second by Claggett to approve the minutes of the February 24, 2026, meeting. All members voted aye. Motion carried.

PUBLIC INPUT

Steve Sibson spoke briefly on the half cent tax proposed by the governor. Steve indicated that this money does not go into the budget but rather into a special fund for property tax relief

VSO OFFICE UPDATE

VSO Thomas shared that his office is fully staffed again and added that his new staff is a great addition to the county. He shared that no new counties have asked Davison County to assist them with their veterans. Thomas further stated that the counselor will be coming twice a month because of the need for the services and will be utilizing a room at the North Offices. Thomas also talked to the board about his budget since the new staff has been hired. No action taken.

BURN BAN DISCUSSION

Per the recommendation of Acting Director Weglienter, as well as Mitchell City, Mt. Vernon and Ethan City, and the fire chief, the burn ban will continue in Davison County due to a lack of precipitation. The burn ban will be discussed again at the next commission meeting.

LEMPG AGREEMENT

Motion by Claggett, second by Kiner to allow the chairman to sign off on the LEMPG Agreement Articles Certification. All in favor - aye Motion carried.

ACTING DIRECTOR WEGLEITNER

AD Wegleitner talked to the board about working on updating the county's Hazard Mitigation Plan and needing to meet with District 3. The board welcomed them to come to the 3/24/26 Davison County Commission meeting.

Wegleitner also talked to the board about Kibbee Ditch and provided an update on the project. The Highway Department has cleared one mile of trees and is working on the dirt work. Highway Superintendent Weinberg is willing to continue working on the ditch with approval from the board. The intention is to clean up as much as possible with proper permits and landowners' approval.

SET DATE AND TIME FOR RETAIL ON-SALE LIQUOR LICENSE

Motion by Claggett, second by Kiner to set the date and time for the CJM liquor license on 3/24/26 at 10:00 A.M. The application was filed in the Davison County Auditor's Office for a retail (on sale) liquor license for CJM Consulting at the legal description of Lot 2D, Block 4, Westwood First Addn., Mitchell Township, Davison County, South Dakota. All in favor - aye. Motion carried.

EMPLOYEE CHANGES

Motion by Claggett, second by Blaalid to approve Deputy Treasurer Joleen Butcher to receive her introductory period raise of \$.50 after successful completion on 2/21/26. All in favor - aye. Motion carried.

PHONE VOTE

Motion by Claggett, second by Nebelsick to approve the fuel quote from 3/5/26 for the low bid from Coles Petroleum, Inc. at \$3.0875 (93,000 gallons of diesel #2). All in favor - aye. Motion carried.

Motion by Nebelsick, second by Claggett to approve the purchase of Veg-A Kill Plus 2,4D for the Weed Department at no more than \$7,500. All in favor - aye. Motion carried.

ACKNOWLEDGE VOLUNTEERS

Motion by Nebelsick, second by Claggett to acknowledge the volunteers for Davison County. All in favor - aye. Motion carried.

WEED SUPERVISOR

Supervisor Page talked to the board about the chemical Grazon PD3. Mr. Page is requesting 750 gallons at \$52 a gallon for a total of \$39,000. Motion by Nebelsick, second by Claggett to purchase. All in favor - aye. Motion carried.

SHERIFF HARR

Sheriff Harr brought a quote from First Net for new radios. Radios are \$.99 and operate via a monthly fee of \$29.99 each. Motion by Blaaid, second by Nebelsick to purchase eight radios. All in favor - aye. Motion carried.

Sheriff Harr also talked to the board about training opportunities. The first is 6/22/26-6/24/26 in Sioux Falls for Advanced School Resource Officer. The cost is \$450. Another training opportunity for Deputy Van Horn is AMH training on 6/25/26-6/26/26 at a cost of \$225. Ethan/Mt Vernon schools will reimburse the cost to the county for these trainings. Motion by Kiner, second by Nebelsick to approve. All in favor - aye. Motion carried.

Another training opportunity for street survival training in Sioux Falls on 7/21/26-7/22-26. Sheriff Harr would like to send four deputies at a cost of \$265 per person. Motion by Blaaid, second by Kiner to approve. All in favor - aye. Motion carried.
