CALL TO ORDER

Chairman Reider called the meeting of the Davison County Board of Commissioners to order at 9:00 A.M.. Members of the board present were Claggett, Kiner Nebelsick, Reider, Blaalid. Also present was Auditor Wingert.

PLEDGE

Chairman Reider opened the meeting with the Pledge of Allegiance.

APPROVE AGENDA

Motion by Blaalid, second by Nebelsick to approve the agenda as amended. All in favor - aye.
Motion carried.

APPROVE MINUTES

Motion by Claggett, second by Nebelsick to approve the minutes of the March 24, 2026, meeting. All members voted aye. Motion carried.

PUBLIC INPUT

There was no public input.

2025 ANNUAL REPORT

Auditor Wingert provided the board with the annual report for 2025. Annual report was submitted to the state and published. Full copies are available in the Davison County Auditor's Office.

JERRY OPBROEK- TRAP CLUB

Mr. Opbroek talked to the board about a culvert that was going to be placed by the trap club to help remove sitting water in the ditch. Mr. Opbroek said that he is worried about the culvert with the ditch being so high and with there being a low spot in the road. He is also concerned about losing parking spots for participants/observers when there are events at the Trap Club. The board discussed that this situation is complex. The board said that to fix the water problem, parking spots may be lost. Highway Superintendent Weinberg will work with the board and Mr. Opbroek to find a solution that fits all.

STEVE THIESSE

Steve and his wife, Judy, talked to the board about the drainage issue by their residence. Steve said that they have had water problems in the house since the city put in a water pipeline many years ago. He added that the pipeline hasn't been used for many years. Mr. Thiesse told the board that he and his wife have talked to multiple entities to try to get the help they need to fix this issue and have had no luck. Mrs. Thiesse noted that they have dealt with the water issues for many years. However, now they are trying to get help with fixing the ditches near them for water to flow more freely away from their house. No action was taken. Commissioners will look into the situation.

GORDON FLESCH

Adam and Grant from Gordon Flesch gave an overview of their proposals to umbrella all printers under one vendor. Informational only - no action was taken.

RENEW RETAIL (ON-OFF SALE) MALT BEVERAGE & SD FARM WINE

Motion by Kiner, second by Claggett to approve the renewal for Mike's Corner retail on-off sale malt beverage & SD farm wine for the 2026-2027 year. There were no noted concerns from law enforcement or the public. All in favor - aye. Motion carried.

Davison County Resolution #040726-01
Resolution Combining Precincts
For 2026 Primary Election

Whereas, SDCL 12-14-1 provides for boundary changes of election precincts already established: and

Whereas, it is more cost effective to combine precincts for the Primary Election; and

Whereas, per SDCL 12-14-4 in doing so shall not cause unreasonable waiting time for the voters.

Now therefore, be it resolved by the Board of Commissioners of Davison County that the precincts will be combined to form nine precincts as follows:

Precinct 1 (Rome & Tobin Townships and Ethan Town)
Precinct 2 (Baker, Blendon, Mt. Vernon & Union Townships and Mt. Vernon City)
Precinct 3 (Badger, Beulah, Lisbon & Prosper Townships)
Precinct 4
Precinct 5
Precinct 6 & 8
Precinct 7
Precinct 9
Precinct 10
Precinct 11 & 12
Precinct 13
Precinct 14
Precincts 15 & 16
Precincts 18
Precinct 19
Precinct 20

It is further resolved that this resolution be in effect each year a primary election is held unless repealed or modified by duly enacted resolution.
