## **EXPLANATORY NOTE**

### **SCOPE OF REVISION**

This Ordinance in Revision, cited as the 1989 Revised Ordinances of Springfield, is a revision of all of the Ordinances of the City heretofore adopted except appropriation ordinances, ordinances providing for the issuance of bonds, certain emergency ordinances, and ordinances granting franchises, easements, or contract rights. The subject matter of the revision should be considered with referenced to the General Provisions of Title XV.
